Actions taken at this Meeting do not constitute final Board action and are only Committee recommendations to be considered by the Board at the next Regular Board meeting.

III Adjournment to closed or executive session pursuant to Texas Government Code Sections 551.071; 551.072 and 551.074, the Open Meetings Act, for the following purposes:

A. Legal Matters

Consultation with legal counsel concerning pending or contemplated litigation, a settlement offer, or matters on which the attorney's duty to the System under the Texas Disciplinary Rules of Professional Conduct clearly conflicts with the Texas Open Meetings Laws.

B. <u>Personnel Matters</u>

Deliberate the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer, employee or board member to hear complaints or changes against an officer, employee or board member unless the officer, employee or board member who is the subject of the deliberation or hearing requests a public hearing.

C. <u>Real Estate Matters</u>

Deliberate the purchase, exchange, lease, or value of real property for Agenda items if deliberation in an open meeting would have a detrimental effect on the position of the System in negotiations with a third person.

IV. Additional Closed or Executive Session Authority:

If, during the course of the meeting covered by this Notice, the Board should determine that a closed or executive meeting or session of the Board should be held

or is required in relation to any items included in this Notice, then such closed or executive meeting or session as authorized by Section 551.001 et seq. of the Texas Government Code (the Open Meetings Act) will be held by the Board at that date, hour and place given in this Notice or as soon after the commencement of the meeting covered by the Notice as the Board may conveniently meet in such closed or executive meeting or session concerning:

Section 551.071 - For the purpose of a private consultation with the Board's attorney about pending or contemplated litigation, a settlement offer, or matters on which the attorney's duty to the System under the Texas Disciplinary Rules of Professional Conduct clearly conflicts with the Texas Open Meetings Laws.

Section 551.072 - For the purpose of discussing the purchase, exchange, lease or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the governmental body in negotiations with a third person.

Section 551.073 - For the purpose of considering a negotiated contract for a prospective gift or donation to the System if deliberation in an open meeting would have a detrimental effect on the position of the System in negotiations with a third person.

Section 551.074 - For the purpose of considering the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer, employee or board member to hear complaints or changes against an officer, employee or board member unless the officer, employee or board member who is the subject of the deliberation or hearing requests a public hearing.

Section 551.076 - To consider the deployment, or specific occasions for implementation of security personnel or devices, or a security audit.

Section 551.082 - For the purpose of considering discipline of a student or to hear a complaint by an employee against another employee if the complaint or charge directly results in a need for a hearing, unless an open hearing is requested in writing by a parent or guardian of the student or by the employee against whom the complaint is brought.

Section 551.084 - For the purpose of excluding a witness or witnesses in an investigation from a hearing during examination of another witness in the investigation. Should any final action, final decision, or final vote be required in the opinion of the Board with regard to any matter considered in such closed or executive meeting or session, then such final action, final decision, or final vote shall be at either:

A. The open meeting covered by this Notice upon the reconvening of the public meeting, or

B. At a subsequent public meeting of the Board upon notice thereof, as the Board shall determine.



Note: In August 2024, HCC timely submitted its Legislative Appropriations Request to the Legislative Budget Board for funding consideration. CSSB 1, which passed both chambers, is now the principal budget bill for state appropriations and it maintains HCC's funding request. This consideration is now subject to deliberation by budget conferees.

*The House-adopted floor Amendment No. 362 (by Ward Johnson) strikes "\$56,000,000" and substitutes "\$30,000,000." The latter amount moved to Article XI and is now subject to budget conferees' deliberations. Slide revised May 8, 2025.

TEXAS GRANTS PROGRAM CONFERENCE COMMITTEE ON SB1

(Article III—Higher Education)



* Texas Grants is a need-based program for Texas resident students pursuing their first degree. Both the House and Senate maintain introduced bills' funding. The House provides \$202.4M in additional funding for Texas Grants for the 2026-2027 biennium.

TEXAS TRANSFER GRANTS PROGRAM CONFERENCE COMMITTEE ON SB1

(Article III—Higher Education)



* The Texas Transfer Grants program is a need-based program that helps students who have earned an associate degree transfer to a four-year university in Texas. The House transfers \$12.4M in FY27 to Texas Grants to treat students who received TEOG awards as Texas Grant renewal students.

TEXAS EDUCATION OPPORTUNITY GRANT CONFERENCE COMMITTEE ON SB1

(Article III—Higher Education)



* Texas Education Opportunity Grant program provides aid to students with financial need and enrolled at either public junior colleges, state colleges, or technical institutes. The House provides an additional \$93.5M for the TEOG program.

HB 1 (Bonnen) General Appropriations Bill

Identifies state appropriations for all state agencies and other entities, including higher education institutions, for the 2026-2027 biennium.

In lieu HB 1, SB 1 advances as principal budget bill. February 25, 2025.*

<u>SB 1</u> (Huffman) *General Appropriations Bill*

Identifies state appropriations for all state agencies and other entities, including higher education institutions, for the 2026-2027 biennium.

Conference committee set. April 24, 2025.*

HB 500 (Bonnen)

Relating to making supplemental appropriations and reductions in appropriations and giving direction and adjustment authority regarding appropriations

Status:

Passed House; referred to Senate Committee on Senate Finance. May 23, 2025.*

HB 2856 (Howard)

Relating to a study concerning feasibility of implementing a statewide system for coordinating clinical training placements.

Status:

Passed House; voted favorably from Senate Education K-16; recommended for Local/Uncontested Calendar. May 16, 2025.*

SB 1908 (Zaffirini)

Relating to a study concerning feasibility of implementing a statewide system for coordinating clinical training placements.

Status:

Committee action pending Senate Education K-16. April 29, 2025.*

HB 3923 (Bell)

Relating to state employment opportunities for individuals who do not hold a bachelor's degree.

Status:

Passed House; pending action Committee on Senate Business and Commerce. May 23, 2025.*

SB 1041 (Parker)

Relating to state employment opportunities for individuals who do not hold a bachelor's degree.

Status:

Introduced and referred to committee on Senate Business & Commerce. February 24, 2025.*

HB 2110 (VanDeaver)

Relating to public higher education – students in grades 9 – 12 eligible to enroll at no cost in dual credit courses..., governing board shall exempt payment of tuition and required fees for dual credit courses.

Status:

Passed House; Senate concurred with House amendments; sent to the Governor. May 15, 2025.*

SB 1786 (Creighton)

Relating to public higher education – students in grades 9 – 12 eligible to enroll at no cost in dual credit courses..., governing board shall exempt payment of tuition and required fees for dual credit courses.

Status:

Senate concurred with House amendments; sent to the Governor. May 15, 2025.*

HB 5303 (Troxclair)

Relating to the vote required by the governing body of a taxing unit to adopt an ad valorem tax rate that exceeds the voter-approval tax rate or authorize the issuance of tax bonds

Status:

Introduced and referred to committee on House Ways and Means. April 7, 2025.*

SB 2529 (Bettencourt)

Relating to the vote required by the governing body of a taxing unit to adopt an ad valorem tax rate that exceeds the voter-approval tax rate or authorize the issuance of tax bonds.

Status:

Passed Senate; reported favorably from House Ways and Means; meeting set at 9 am. May 22, 2025.*

HB 4499 (Shaheen)

Relating to the governance of public institutions of higher education, including review of curriculum and certain degree and certificate programs, the powers and duties of a faculty council or senate.

SB 37 (Creighton)

Relating to the governance of public institutions of higher education, including review of curriculum and certain degree and certificate programs, the powers and duties of a faculty council or senate.


