Actions taken at this Meeting do not constitute final Board action and are only Committee recommendations to be considered by the Board at the next Regular Board meeting.

# III. Adjournment to closed or executive session pursuant to Texas Government Code Sections 551.071; 551.072 and 551.074, the Open Meetings Act, for the following purposes:

### A. Legal Matters

Consultation with legal counsel concerning pending or contemplated litigation, a settlement offer, or matters on which the attorney's duty to the System under the Texas Disciplinary Rules of Professional Conduct clearly conflicts with the Texas Open Meetings Laws.

### B. <u>Personnel Matters</u>

Deliberate the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer, employee or board member to hear complaints or changes against an officer, employee or board member unless the officer, employee or board member who is the subject of the deliberation or hearing requests a public hearing.

### C. Real Estate Matters

Deliberate the purchase, exchange, lease, or value of real property for Agenda items if deliberation in an open meeting would have a detrimental effect on the position of the System in negotiations with a third person.

# IV. Additional Closed or Executive Session Authority

If, during the course of the meeting covered by this Notice, the Board should

determine that a closed or executive meeting or session of the Board should be held or is required in relation to any items included in this Notice, then such closed or executive meeting or session as authorized by Section 551.001 et seq. of the Texas Government Code (the Open Meetings Act) will be held by the Board at that date, hour and place given in this Notice or as soon after the commencement of the meeting covered by the Notice as the Board may conveniently meet in such closed or executive meeting or session concerning:

Section 551.071 - For the purpose of a private consultation with the Board's attorney about pending or contemplated litigation, a settlement offer, or matters on which the attorney's duty to the System under the Texas Disciplinary Rules of Professional Conduct clearly conflicts with the Texas Open Meetings Laws.

Section 551.072 - For the purpose of discussing the purchase, exchange, lease or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the governmental body in negotiations with a third person.

Section 551.073 - For the purpose of considering a negotiated contract for a prospective gift or donation to the System if deliberation in an open meeting would have a detrimental effect on the position of the System in negotiations with a third person.

Section 551.074 - For the purpose of considering the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer, employee or board member to hear complaints or changes against an officer, employee or board member unless the officer, employee or board member who is the subject of the deliberation or hearing requests a public hearing.

Section 551.076 - To consider the deployment, or specific occasions for implementation of security personnel or devices, or a security audit.

Section 551.082 - For the purpose of considering discipline of a student or to hear a complaint by an employee against another employee if the complaint or charge directly results in a need for a hearing, unless an open hearing is requested in writing by a parent or guardian of the student or by the employee against whom the complaint is brought.

Section 551.084 - For the purpose of excluding a witness or witnesses in an investigation from a hearing during examination of another witness in the investigation. Should any final action, final decision, or final vote be required in the opinion of the Board with regard to any matter considered in such closed or executive meeting or session, then such final action, final decision, or final vote shall be at either:

- A. The open meeting covered by this Notice upon the reconvening of the public meeting, or
- B. At a subsequent public meeting of the Board upon notice thereof, as the Board shall determine.

### DISCUSSION

Regular review of student success measures provides the Board of Trustees with a clear lens through which to evaluate the effectiveness and direction of college initiatives. These measures—such as retention, persistence, credit accumulation, and enrollment in credentials of value—offer timely insights into how well the institution is supporting students in achieving their academic and career goals.

This data-informed approach also plays a critical role in informing the budgeting process. Understanding where progress is being made and where additional support may be needed allows for more strategic allocation of resources. As the College continues to invest in student-centered programs and services, regular engagement with success metrics ensures that financial decisions are grounded in evidence and focused on maximizing impact.

## **COMPELLING REASON AND BACKGROUND**

The College has committed to a data-informed approach to improving student outcomes and institutional effectiveness. Over recent years, initiatives aimed at enhancing retention, persistence, credit accumulation, and enrollment in credentials of value have been implemented across academic and student support services. These leading indicators serve as early signals of progress and help identify areas requiring strategic attention.

Regular review of student success measures enables the Board of Trustees to evaluate the trajectory of college initiatives and their alignment with institutional goals. These metrics not only reflect the effectiveness of current strategies but also inform resource allocation and budgeting decisions. By monitoring trends in student achievement, the Board ensures accountability, promotes continuous improvement, and supports the College's mission to foster equitable and meaningful educational outcomes.

It is recommended that the Board continue regular review of student success metrics as part of its strategic oversight and planning responsibilities. These measures provide essential insight into the effectiveness of institutional initiatives and should be integrated into future budget discussions to ensure resources are aligned with efforts that drive measurable improvement in student outcomes.




Leading Indicators are metrics that are used to formatively assess whether initiatives implemented now are likely to improve student outcomes several years in the future.



# Enrollment by Risk Status









# Course Success in Developmental Coursework, AY 2024 vs. AY 2025



# Course Success in Highest Enrollment Courses, AY 2024 vs. AY 2025




# Success Rate by Scholarship for AY 2025




# **Building Academic Momentum**

Credit completion in the first year: This increased momentum toward degree extends to the first year.




# Retention and Positive Outcomes

The retention rate is the rate at which students remain enrolled at the same institution


The persistence rate is the rate is the rate at which students remain enrolled at the same institution or another institution.

Because HCC offers short term certificates, like many institutions HCC includes completions in the persistence rate. This is sometimes referred to as the positive outcome rate.






# Dual Credit Success Rates




# Dual Credit Students Earning 15 Hours for the First Time
